**Ministerial Regulation**  
**Prescribing competent officer identification card**  
**B.E. 2553 (2010)**

By virtue of the provisions of Paragraph three of Section 12, and Section 22 of the Statistics Act, B.E. 2550, of which comprise provisions concerning restrictions of rights and liberty of person, which shall be exercised by the provision of law in accordance with Section 29 in conjunction with Section 33, Section 35, Section 41, Section 45, and Section 56 of the Constitution of the Kingdom of Thailand, the Minister of Information and Communication Technology issues Ministerial Regulation as follows:

Clause 1 The identification card of the competent officer shall be in accordance with the form attached to this Ministerial Regulation.

Clause 2 The Director-General of the National Statistical Office shall issue the identification card of the competent officer.

Clause 3 Photograph attached to the competent officer identification card shall be taken less than six months prior to the date of application. The 2.5 x 3.0 cm in size, directly facing camera, non-hat, and sunglasses is required.

Clause 4 The competent officer identification card shall be valid for the period specified in the card but shall not exceed than six years from the date of issue.

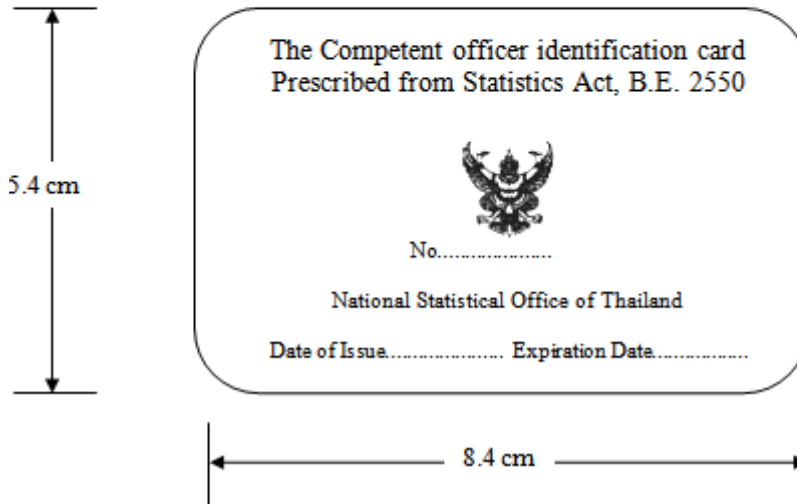

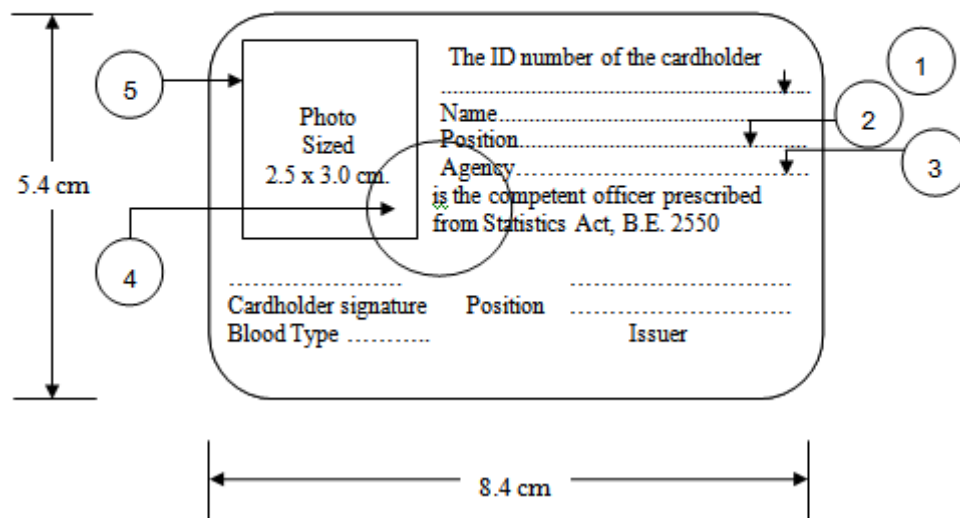

2. Position of the card holder (if applicable)
3. Agency of the card holder (if applicable) such as the Bureau of....., Province.....
4. National Statistical Office Approved Stamp on the lower right corner of the photo
5. For the photo, in case of being a government official, one should dress in a white state official's uniform. If the competent officials are of private agencies, dress in a polite outfit or a modern western suit.
