**Notification of the National Statistical Office**  
**Re: Statistical Data Service of the National Statistical Office (No.2)**  
**B.E. 2556 (2013)**

The section 17 of The Statistical Act, B.E. 2550 (2007) on providing statistical service to the agencies, the private sectors and the general public allows the National Statistical Office to provide all the information that can be disclosed as a service to the general public with the cost, as appropriate as for statistical service, that may be charged according to the criteria and rates prescribed by the National Statistical Office.

To ensure an orderly and consistently standardized service, and to promote the efficient and extensive use of statistical data, the National Statistical Office hereby issues the criteria and rates for the statistical data service as follows:

**Clause 1 In this Notification:**

“Chief” means the Director-General of the National Statistical Office.

“User” means agencies according to section 4 of The Statistical Act, B.E. 2550 (2007), namely government agencies, state enterprises, public organizations, local administration organizations and other state agencies, including private organizations and the general public both in and outside the country that request for statistical data service of the National Statistical Office

“Statistics” means statements or figures compiled from collected data.

“Microdata” means individual or specific information obtained under The Statistical Act, B.E. 2550 (2007), which already passes the accuracy, completion and consistency check, and thus is ready to apply for the compilation of statistics.

**Clause 2 Types of Statistical Data Service of the National Statistical Office:**

- (1) Statistics
- (2) Microdata

**Clause 3 Request for Statistical Data Service:**

User may request for statistical data service at The National Statistical Office, The government complex, Building B (South), Chang Wathana Road., Thung Song Hong, Laksi, Bangkok 10210 or via website: [www.nso.go.th](http://www.nso.go.th) e-mail : [services@nso.go.th](mailto:services@nso.go.th). Terms and procedures for all types of statistical data service are stated in the Attachment to this Notification.

**Clause 4 Statistical Data Service and Service Charges:**

The chief or person authorized by the chief shall countersign the permission to statistical data service. The charges for all types of statistical data service are stated in the Attachment to this Notification.

The charges for statistical data service shall be exempted for the following users: public and private educational institutions, faculties and researchers in both public and private educational institutions and university students.

In the case where user without the charge exemption right wishes to obtain a statistical data service charge exemption or deduction, a written notice together with reasons for the charge exemption or deduction must be filed with officer in order that the chief or person authorized by the chief shall consider the reasons to give the permission to this charge exemption or deduction case by case.

**Clause 5 The permission to request for any other statistical data services besides the services in this Notification is at the discretion of the chief or person authorized by the chief case by case.**

This Notification shall apply in the case where the provisions of any previously declared Notifications or criteria of the National Statistical Office on statistical data service are contrary to or inconsistent with this Notification.
